ARTICLE I PURPOSE

The purpose of this agreement is to establish the terms and conditions under which the UNIVERSITY and Santa Clara County Office of Education will cooperate in the use of clinical facilities for the purpose of providing clinical training for students of the UNIVERSITY.

The UNIVERSITY and Santa Clara County Office of Education agree that the use of clinical facilities for the purpose of providing clinical training for students of the UNIVERSITY is a mutually beneficial activity and that this agreement is intended to facilitate such use.
